# Follow-up to the Special Church Council Meeting

Appropriate way to proceed is sending a letter to the congregation; seconded by Russ Mildenstein and Trish Varcarcel;

9 council members approved with 2 abstentions.

## Church Council Continued...

Agreement between St. Paul's and Vicar Phil Beck.
Trish Valcarcel, on behalf of the Call Committee, motioned to
review the presented agreement between St. Paul's and Vicar
Phil Beck for discussion; seconded by Mary Ann Ferguson and
Ed Chaney.

The agreement is for a half-time (25 hours) covenant agreement with Seminarian Philip J. Beck to be performed at St. Paul's Lutheran Church and is agreed to by the church council. The Rev. Seminarian Philip J. Beck, and the Office of the Bishop of the Delaware - Maryland Synod of the Evangelical Lutheran Church in America.

• The agreement is effective September 11, 2019 until December 30, 2019. It may be terminated upon a 30-day notice with the approval of the Bishop.

Note: Vicar Phil has a prior engagement and not able to preach on Sunday, September 15th.

- Once the agreement is signed by all parties, it becomes a legal binding contract.
- Once the Office of the Bishop signs the agreement, this allows Vicar Phil to preside over the elements.
- Monthly compensation for this half-time covenant position is \$2,333 (salary) + mileage at the current IRS rate.
- During the interim, who can the Office Administer go to for guidance and questions? Trish Valcarcel volunteered to be the point of contact.
- Suggest putting a list together of all the church members and their roles and functions at St. Paul's by committee for the Church Office.

After discussion, Trish Valcarcel motioned to approve the presented agreement between St. Paul's and Vicar Phil Beck; seconded by Mary Ann Ferguson. Council approved.



# **What Comes Next?**

The significant change for pastors, congregations and the synod, will correlate with the pastor's calling. In every situation there are special needs and opportunities to show love for one another, as well as prepare for a brighter future.

### Step 1

Pastor retires or resigns

### Step 2

Synod appoints an interim pastor for approval by council (Interim pastor is NOT available for call to that congregation)

### Step 3

Transition team is chosen for purpose of completing Ministry
Site Profile

### Step 4

At completion of Ministry Site
Profile a Call Committee is
chosen by council

There are significant differences in the process of hiring an employee to a company and the calling of a pastor. The Call Process of a Pastor is a patient one that requires time, stringent research and prayer, as well as the cooperation of the pastoral candidate, the synod, and the congregation for the interdependent process to function.

### Step 5

Synod Pastor meets with Call Committee to give instructions

### Step 6

MSP is officially sent to Synod office for candidate search

### Step 7

Synod office forwards potential candidate information to Call Committee for review and interview

### Step 8

Potential Candidate is Seminarian
Student with two semesters left—to be a
contractual 'temp to perm'
position (or 'rent to own')

In final reflections, the process is to guide you to the question and answer of the following quote, "In our deepest reflection and prayer, do we believe God is moving us to call this pastor to speak for Christ and serve Christ in our parish?" We must have faith that God's presence will aid in your discernment.

### Step 9

Call Committee interviews
Seminarian (Vicar) and recommends
to Council for contractual hire while
Vicar finishes seminary

### Step 10

Council approves contract for Fall 2019 with re-negotiations to happen for Spring 2020 Semester

### Step 11

Spring 2020 Call Committee recommends to Council/Congregation for full call to be extended

### Step 12

Congregational meeting for vote to extend

Call to Vicar
